ARTICLE I. Name of Student Organization

The organization shall be called Cheese Club at UC San Diego.

ARTICLE II. Statement of Purpose

The goal of this organization is to help students connect with others over their shared love for cheese. Cheese is an almost universally loved food that will attract people of all majors, standings, and years, and provide a casual environment for people to interact. We will host many cheese-related events, such as "R&Brie" study sessions, cheese fondue nights, and collaborations with other student organizations, in order to provide the perfect backdrop for students to mingle and make new friends.

ARTICLE III. Nonprofit Statement

Cheese Club at UC San Diego is a non-profit student organization.

ARTICLE IV. Requirements for Membership

We welcome anyone that is interested in meeting other students or simply have an interest in cheese.

ARTICLE V. Frequency of Organization Meetings

Meeting times are flexible and will be determined by majority vote. There is no required number of meetings each quarter or year.

ARTICLE VI. Qualifications for Holding Office and Methods of Selecting and Replacing Officers

Only registered UC San Diego students may hold office in the organization. Only registered UC San Diego students may vote in elections for the selection of the organization's officers.

The CEO will approve all activities the club will undertake and will lead the meetings. The COO will handle the paperwork involved with filing for events and keep meeting notes. The CFO will handle all monetary expenditures, including fundraising and event-related expenses, and will keep track of the budget. The CMO will be in charge of the social media platforms and advertising for the club. The Event Coordinators are responsible for organizing fun and interesting events throughout the school year. Election of officers will take place during early Spring Quarter, and they will hold office for the entire year until the next reelection. To remove an officer, a member must provide a valid reason, and more than half of the members must vote for the removal. For any office other than the CEO, the member who provided the reason will take over that office until the next meeting, where a replacement officer will be selected.

ARTICLE VII. Risk Management

Cheese Club at UC San Diego is a registered student organization at the University of California, San Diego, but not part of the University itself.

Cheese Club at UC San Diego understands that the University does not assume legal liability for the actions of the organization.

Cheese Club strives to create a safe and clean environment for eating on campus. Prior to food distribution events, Cheese Club officers will send out a survey to gauge any food allergies. Eating cheese is not recommended for people who are lactose intolerant. Other risks include stomach issues depending on the quality or amount of cheese consumed. In the case of any serious injury or health condition, we will call for medical assistance.

ARTICLE VII. SECTION 1. IN CASE OF THE PROVISION OF MEDICAL ASSISTANCE

In the event that Cheese Club at UC San Diego provides medical assistance to the community, all volunteers will work under the direction of licensed professionals (doctors, nurses, counselors, etc.). The University does not recommend that students provide medical assistance.

ARTICLE VIII. Financial Management

We will submit a budget to the A.S. financial committee quarterly. In the event that an event requires a fee beyond our stated budget, we will raise funds to cover that expense.
