

# **BREAKIN' CLUB – BODY ROCK AT UCSD CONSTITUTION – 2018-2019 ACADEMIC YEAR**

## **ARTICLE I. NAME OF STUDENT ORGANIZATION\***

**The organization shall be called Breakin' Club – Body Rock at UCSD.**

## **ARTICLE II. STATEMENT OF PURPOSE\***

*THE PURPOSE OF THIS ORGANIZATION IS TO EDUCATE, PROMOTE, AND PRESENT THE ART AND HIP-HOP DANCE ELEMENT OF B-BOYING/B-GIRLING (BREAKDANCING) IN AN ENJOYABLE MANNER AS A NON-PROFIT ORGANIZATION. EDUCATION WILL INCLUDE THE INSTRUCTION OF MULTIPLE STYLES AND MOVES THROUGH PEER HELP. PROMOTION WILL INCLUDE HOLDING EVENTS SUCH AS COMPETITIONS AND GATHERINGS WITH LOCAL CREWS AND OTHER UC'S, AS WELL AS EVENTS ON CAMPUS. MEMBERS WILL DEVELOP THEIR DANCE SKILLS AND HAVE OPPORTUNITIES TO PERFORM WITH EACH OTHER.*

## **ARTICLE III. NONPROFIT STATEMENT\***

**Breakin' Club – Body Rock at UCSD is a non-profit student organization.**

## **ARTICLE IV. REQUIREMENTS FOR MEMBERSHIP\***

- *Any person with an interest in b-boying/ b-girling is encouraged to join.*
- *To become an official member, a prospective member must attend regular practices weekly.*
- *Those who are not official members may still attend practices and meetings.*
- *There are no tryouts and anyone is free to join.*
- *There are no fees or dues required to join. This is a community organization that is promoting Hip-Hop through breaking.*

## **ARTICLE V. FREQUENCY OF ORGANIZATION MEETINGS\***

*Education will take place by holding at least two official sessions (practices) a week. There will be two official sessions each week, but multiple unofficial sessions will take place during each week in which everyone is encouraged to join in as well. Minutes will not be taken.*

## **ARTICLE VI. QUALIFICATIONS FOR HOLDING OFFICE AND METHODS OF SELECTING AND REPLACING OFFICERS\***

**Only registered UCSD students may hold office in the organization. Only registered UCSD students may vote in elections for the selection of the organization's officers.**

*There will be a required four principle membership position each academic school year.*

- *Only those who attend sessions regularly, both official and unofficial, will be considered for principle membership.*
- *All principle members have equal say in making decisions and voting.*
- *Principle members must vote on all decisions involving promotional events and the usage of funds. Majority rules.*
- *Those who want to get more involved by setting up and organizing promotional events are encouraged to become principle members.*

● **Positions Under Principle Membership:**

- **Co-presidents:** *These 2 people are responsible for overseeing all other positions, events, practice sessions to make sure all things are in order as they should be. They are also responsible for helping out when assistance is needed, managing the organization's e-mail account, maintaining contact with CSI and Recreational Facilities' staff, and must confirm any final decisions with other principle members. Also responsible for finances. This includes, but is not limited to, collecting money for Body Rock apparel, contacting AS for funds for events, collecting money from fundraisers, keeping records of Body Rock's finances, and the distribution of finances.*
- **Vice President/Public Relations Officer:** *He/she is responsible for the connecting the club to the UCSD dance community, the San Diego/SoCal Bboy Community, and the UCSD student body in general. He/she will also be responsible for advertising for club, organizing fundraisers, and being an assistant to the co-presidents. He/she is responsible for reserving spaces for events along with finding out about when, where, and how events can be set up for the club. This also includes club socials, whether it be on campus or off campus. Along with an assisting committee, he/she can plan, and publicize for the event.*
- **Choreography Coordinator:** *He/she is responsible for helping the co-presidents lead the choreography team of Body Rock His/her responsibilities include planning practice times separate from session times for members who are interested in being part of the choreography team, communicating with the organizations involved in the club's performances, finding choreographers, and making sure the practices run smoothly.*
- **Replacing Principle Members:** *A principle member will stay in position as long as he/she is allotted to in accordance to UCSD's CSI rules and regulations. Principle members are the only ones who may vote another principle member out of position, in which case a unanimous decision is required by the remaining principle members to vote one out. In this situation, only the remaining principle members can vote on a new principle member into position, in which case a unanimous decision is required in order to vote on a new principle member.*
- **Duties of Principle Members:** *Principle members will decide on issues, actions, and policies that affect the club through voting. A unanimous decision will be required before any policy or actions go into affect.*

ARTICLE VII. RISK MANAGEMENT\*

**BREAKIN' CLUB – BODY ROCK at UCSD is a registered student organization at University of California, San Diego, but not part of the University itself.**

**BREAKIN' CLUB – BODY ROCK at UCSD understands that the University does not assume legal liability for the actions of the organization.**

Possible risks associated with Body Rock (and breakdancing) include but are not limited to:

- Minor or serious injury to the body
- Acute injuries to the neck, wrist, elbow, knee, and groin
- Coming in contact with dirt/dust/etc. on floor may cause allergic reactions

**ARTICLE VII. SECTION 1. IN CASE OF THE PROVISION OF MEDICAL ASSISTANCE**
