Triton WoW Constitution

2020-2021 School Year

ARTICLE I

NAME OF CLUB

Section 1. The name of this club shall be Triton WoW.

ARTICLE II

PURPOSE OF CLUB

The purpose of Triton WoW is to aspire to create epic entertainment experiences for student gamers that play World of Warcraft at the University of California, San Diego. Our organization will often work with a combination of several independent on-campus gaming organizations that each represents a different gaming genre and student community, under Triton Gaming. Through Triton WoW, our team strives to create an exciting, diverse, and all-inclusive gaming environment on campus through high-quality live events.

For the 2019-2020 school year, the gaming divisions that Triton WoW will work with include: League of Legends, Hearthstone, StarCraft, Fortnite, Rainbow6, Overwatch, Counter Strike, Street Fighter, Melee, Smash 4, DOTA 2, Rocket League, Heroes of the Storm, Video Game Development, PUBG, OSU. All of which are under Triton Gaming.

By working with other gaming organizations, our goal is always to empower – not employ – others to bring out the best in their communities.

ARTICLE III

NONPROFIT STATEMENT

Section 1. Triton WoW at UCSD is a non-profit student organization.

ARTICLE IV

REQUIREMENTS FOR MEMBERSHIP

- Section 1. Club members may not be on academic or social probation.

 Members shall not be discriminated against based on the following:
 - 1) Year of Graduation
 - 2) Gaming Aptitude
 - 3) Personal views on the current roster of officers

- 4) Gender or sexual orientation
- 5) Association with any other gaming or non-gaming organization
- 6) Political Affiliation
- 7) Disabilities
- Section 2. No fees are required for membership. A student becomes a member by attending events and providing the club with their email to be added to the club's roster.

ARTICLE V.

FREQUENCY OF ORGANIZATION MEETINGS

- Section 1. The executive council, consisting of the Division Head and Division Leaders will meet at least once a month.
- Section 2. The organization will hold a general body meeting once a quarter and smaller meetings once a month.
- Section 3. The Division Leader that is assigned to the Secretary tasks shall record the minutes for each meeting that is held. The information recorded will be shared to members that were absent and reviewed by the executive council as a reference.

ARTICLE VI

QUALIFICATIONS FOR HOLDING OFFICE AND METHODS OF SELECTING AND REPLACING OFFICERS

- Section 1. Only registered UCSD students may hold office in the organization. Only registered UCSD student may vote in elections for the selection of the organization's officers.
- Section 2. The executive council will consist of the Division Head and three Division Leaders. They will hold office until they decide to step down. New council members will be elected into office by the current executive council members and they will assume their position on the first day of the following school year.
- Section 3. Officers will be elected by the first day of June and will assume their position on the first day of the following school year. They will hold office for the entirety of that year.
- Section 4. Club officers must be currently enrolled, have a minimum of a 2.0

Cumulative Grade Point Average (GPA), must maintain at least 8 units per quarter, and must not be on academic or social probation.

Section 5. Club elections for the next year will be held no later than May 1st.

The election will use anonymous ballots by club members that qualify as "active" and are current UCSD students.

- Section 6. Members that are deemed as "active" are eligible for office. This includes:
 - 1) Attending a majority of all meetings
 - 2) Attending at least one live event and one online event each quarter
 - 3) Attending at least one social/community event
 - 4) Being socially active with other members of the organization
- Section 7. Officers will constitute a subcommunity to the executive council.
- Section 8. Chief Community Officer A. Provide interested parties with information regarding club events,

social events, and endeavors.

B. Be the public point of contact for any external inquiries regarding the event.

Section 9. Chief Media Officer A. Oversee all external networking,

advertising, and promotion for the Triton WoW division and its events.

B. Be the public point of contact for any external inquiries regarding the

organization.

Section 10. Chief Financial Officer A. Over

A. Oversee all financial and fundraising activities pertaining to the organization.

B. Be the public point of contact for any external inquiries regarding an event or suggestions for future fundraising events.

- Section 11. All elected officers and club members may be subjected to impeachment and removal by a two-thirds majority vote of the total membership.
- Section 12. Grounds for impeachment are negligence and any form of misconduct which is damaging to the club. The interpretation of the term negligence is hereby recognized as: Missing (3) or more consecutive general officer meetings/events without informing the Executive Council. An officer/member may be impeached/removed only under the following conditions: there must be a quorum present during impeachment/removal; two-thirds of the membership must vote; prior to impeachment/removal there must be one week's notice of intent publicized.
- Section 13. Any officer vacancies shall be filled by an election held within two weeks.

ARTICLE VII

RISK MANAGEMENT

- Section 1. Triton WoW at UCSD is a registered student organization at the University of California, but not part of the University itself.
- Section 2. Triton WoW at UCSD understands that the University does not assume legal liability for the actions of the organization.
- Section 3. Possible risks associated with Triton WoW's activities are as follows:
 - 1. Working with heavy equipment (i.e. setting up gaming PCs, Display monitors, CRTs).
 - 2. Working with wires and cables (setting up ethernet, wiring connections for multiple displays, working with power strips)

Please note, our organization spends *a lot* of time dedicated to our events. Some events may require students to set up as early as 8AM or stay as late as 11PM. **No one is obligated to stay for the entire duration of an 8AM – 11PM event.** While everyone is expected to do (2) 2-hour shifts with breaks in-between, we value the health and well-being of our officers above all.

However, we have noticed that officers will often enjoy and care about the event so much that some people *choose* to work long hours. We do our best to urge officers to take breaks and stay hydrated, but we ultimately cannot be held responsible for the choices of any individual.

ARTICLE VIII

FINANCIAL MANAGEMENT

- Section 1. The organization will finance activities through fundraising events that may include food and/or beverages.
- Section 2. All money that is earned or gathered by the organization will be kept in a small safe that is handled by the Chief Financial Officer

ARTICLE IX

AFFILIATION WITH OTHER GROUPS

- Section 1. Triton WoW will be affiliated with Triton Gaming at UCSD.
- Section 2. This affiliation means that members of Triton WoW may also be members of Triton Gaming.

ARTICLE X

RESPONSIBILITIES

Section 1. This club accepts full financial responsibility for all activities that bear its name as official sponsor, and will adhere to college regulations. All publicity for an event must bear the name of the sponsoring club.

ARTICLE XI

RIGHT TO ACT

Section 1. Any club officer, club member does not have the right to incur any debt or become involved in any business under the title or by

implying the title of a club in any way unless given full authority to do so by the club.

ARTICLE XII

AMENDMENTS TO CONSTITUTION

Section 1. Any amendment change requires a two-thirds vote at a general club meeting to be approved.
