

ARTICLE I. NAME OF STUDENT ORGANIZATION

The organization shall be called En Route at UC San Diego.

ARTICLE II. STATEMENT OF PURPOSE

En Route's goal is to create a community of artists that focuses on the merging of everyone's respective mediums and expanding the skill sets of members through collaborative multimedia projects. Each quarter will be focused on a different collaborative art piece centered around a conceptualized theme. The exhibition of our collaborative work may range from being shown in a gallery setting, an experimental film, a zine, an editorial spread, etc. The organization will also host monthly public events focused on specific art practices to allow for training, networking, and education opportunities for UC San Diego students. En Route hopes to uplift artists in the organization by highlighting their individual work both in posts on social media and through specialized workshops. In doing so, they may be connected with different artists on campus so as to facilitate creative connections in the majorly STEM-based environment that is UC San Diego.

ARTICLE III. NONPROFIT STATEMENT

En Route at UC San Diego is a non-profit student organization.

Article IV: REQUIREMENTS FOR MEMBERSHIP

All En Route members must be registered undergraduate students at UC San Diego. General members will be selected based on an application that includes either a portfolio, statement of artistic vision and passion, or work created in previously held En Route workshops to show sustained interest in the organization. New members will be approved under the condition of majority approval from the executive committee.

ARTICLE V. FREQUENCY OF ORGANIZATION MEETINGS

Meetings will be held monthly for the executive committee and weekly for team meetings. Meeting minutes for general meetings will be posted weekly prior to the meeting. Members will be notified of any updates made to the meeting minutes if changes are made during or after meetings. Individual team and project-based meetings will be held when necessary and will be at the discretion of each respective subteam leader.

ARTICLE VI. QUALIFICATIONS FOR HOLDING OFFICE AND METHODS OF SELECTING AND REPLACING OFFICERS

Officers shall consist of the President, Vice President, Finance Director, Finance Coordinator, Marketing Director, Marketing Coordinator, Events Director, Events Coordinator, Media Director, and Media Coordinator.

Only registered UC San Diego students may hold office in the organization. Only registered UC San Diego students may vote in elections for the selection of the organization's officers. To be selected as a member of the executive committee, one must be in good academic standing (2.5 GPA or above). An application must be

submitted to support their candidacy for the role. En Route must hold a general vote among all members of the organization. A majority two-thirds vote will be sufficient in establishing a member as an officer of the executive committee. Executive Committee officer positions will be replaced or renewed yearly or when the officer steps down, whichever comes first. Principal members get priority for executive positions, though all EnRoute members are eligible to apply.

ARTICLE VII. RISK MANAGEMENT

En Route at UC San Diego is a registered student organization at the University of California, San Diego, but not part of the University itself. En Route at UC San Diego understands that the University does not assume legal liability for the actions of the organization. In order to avoid copyright claims and legalities, any and all content associated with En Route shall be the intellectual property of the members, unless stated otherwise and credited to the original source.

ARTICLE VIII. FINANCIAL MANAGEMENT

En Route aims to organize donation events and fundraising activities throughout the year conditional to the amount of money needed for each quarterly project. Any funds raised will go to operating costs within the organization, including, but not limited to, promotional materials, props, and media equipment. A principal member shall be appointed as the Finance Director to oversee all financial responsibilities for the organization with assistance from the Finance Coordinator.
