# Air Force Reserve Officer Training Corps (AFROTC) Detachment 075 Crosstowns

University of California San Diego Student Chapter Constitution

#### ARTICLE I. NAME OF ORGANIZATION

Section I.01

The organization shall be called Air Force Reserve Officer Training Corps Crosstowns.

Section I.02

The following names and abbreviations may also be used to represent the organization:

- (a) Air Force ROTC Detachment 075
- (b) Air Force ROTC Detachment 075 at UC San Diego
- (c) Air Force ROTC Detachment 075 Crosstowns
- (d) AFROTC Det 075
- (e) AFROTC Det 075 Crosstowns
- (f) AFROTC Det 075 at UC San Diego

## **Article II. Statement of Purpose**

Section II.01

This Air Force Reserve Officer Training Corps Detachment 075 Crosstowns is established for the purpose of connecting cadets for the San Diego State University-hosted Air Force Reserve Officer Training Corps Detachment 075 at the biggest crosstown cadet population, UC San Diego, as well as engaging with students interested in careers in the US Air Force or Federal Employment. AFROTC is a Department of the Air Force program that commissions 2nd

Lieutenants into Active Duty for the United States Air and Space Forces upon completion and runs concurrently with students' undergraduate or graduate educations.

## **Article III. Nonprofit Statement**

Section III.01

The Air Force Reserve Officer Training Corps Detachment 075 Crosstowns at UC San Diego is a non-profit student organization.

## **Article IV. Membership**

Section IV.01

Membership in the organization shall consist of the following grades: Member, Cadet, with the only difference between the two being Cadets are officially enrolled in the Air Force ROTC program at Det 075 at the host unit at San Diego State University.

Section IV.02

A Member in the organization shall be: a student at the University of California, San Diego. A Member shall have all the privileges, duties, and benefits of a Cadet, but will not be required to join the cadet program at AFROTC Det 075 at San Diego State University.

Section IV.03

The term "member" as used throughout these Bylaws shall mean a person holding any class of membership.

#### **Article V. Dues and Finances**

Section V.01

There will be no annual dues for this organization.

Section V.02

Monies required to carry on the activity of the Society may only be received from the parent organization, AFROTC Det 075 unit at San Diego State University or individual contributions by members, and may only be used for activities that recruit for the US Air Force ROTC program.

#### **Article VI. Officers**

Section VI.01

Only registered UC San Diego students may hold office in the organization. Only registered UC San Diego students may nominate members for the selection of the organization's officers.

Section VI.02

The Executive Officers of the organization shall be the Flight Commander, Deputy Flight Commander, and First Sergeant.

Section VI.03

The Executive Officers can be nominated by any member at any time and confirmed by the Detachment 075 Cadre Recruiting Flight Commander at San Diego State University at his or her discretion.

## **ARTICLE VII. Risk Management**

Section VII.01

Air Force Reserve Officer Training Corps Detachment 075 Crosstowns at UC San Diego is a registered student organization at the University of California, San Diego, but not part of the University itself. Air Force Reserve Officer Training Corps Detachment 075 Crosstowns at UC San Diego understands that the University does not assume legal liability for the actions of the organization.

# **ARTICLE VIII. Community Mentor**

Section VIII.01

The community mentor for this organization shall be an Active Duty service member in the US Air Force or Space Force serving as the Cadre Recruiting Flight Commander member at Air Force ROTC Detachment 075 at San Diego State University.

Section VIII.02

The community mentor for this organization will serve as long as they hold the Recruiting Flight Commander position. The mentor shall be responsible for overseeing events held by this organization and ensure they are in accordance with all Department of Air Force policies in regards to recruiting.

## **ARTICLE IX. Affiliation with Other Groups**

Section IX.01

This organization is affiliated with the host unit of US Air Force Reserve Officer Training Corps Detachment 075 at San Diego State University. As such, when representing this organization, all actions must be held to the standards of relevant Department of Air Force regulations, even if members are not enrolled in the AFROTC program.
