ARTICLE I. CLUB GOLF AT UC San Diego

The organization shall be called Club Golf at UC San Diego.

ARTICLE II. STATEMENT OF PURPOSE

Club Golf at UC San Diego seeks to connect golfers in the UCSD community for both casual outings and team tournaments. We strive to provide an inclusive and fun community for all golfers from all backgrounds and skill levels, whether you are just getting started or have been playing competitively.

ARTICLE III. NONPROFIT STATEMENT

Club Golf at UC San Diego is a non-profit student organization.

ARTICLE IV. REQUIREMENTS FOR MEMBERSHIP

Membership with Club Golf at UC San Diego is free and open to all enrolled students, faculty, and staff at the University of California, San Diego. Those with an affiliation to the University of San Diego, California may also join. We do not require any golf experience.

Membership may be attained by filling out the club's Google form and having an active email address. Members who are students, faculty, and staff of UCSD will be the first to be notified of discounted rates on range balls and green fees for club events via email. Members are not required to attend all events, but are highly encouraged to.

Volunteering is not required, but is greatly appreciated.

ARTICLE V. FREQUENCY OF ORGANIZATION MEETINGS

Club Golf at UC San Diego will meet at least twice per quarter. The Vice President will take notes at each meeting, publish the information on social media, and share through email.

ARTICLE VI. QUALIFICATIONS FOR HOLDING OFFICE AND METHODS OF SELECTING AND REPLACING OFFICERS

Only registered UCSD students may hold office in the organization. Only registered UCSD students may vote in elections for the selection of the organization's officers.

There will be six officers of Club Golf at UC San Diego:

- 1. President Conducts administrative duties, manages NCCGA connection, manages external contacts, delegation of tasks
- 2. Vice President Oversees membership, assists president with administrative duties
- 3. Treasurer Tracks payments, creates and holds fundraisers, advises on club funding
- 4. Secretary Take meeting minutes, communicate with members via email, responsible for organization of Google Folder
- 5. Media and Publicity Chair Promotes club on all social media platforms, posts updates on all social media platforms, creates flyers

6. Event Coordinator - Assists and coordinates club events. Events may include range sessions, tournaments, and socials

All officers must participate in volunteering efforts such as tabling, attending events, and in selecting new officers.

Elections for new and reinstallation of officers for the following academic year will be held throughout the year as needed, depending on the current officers' graduation status. Officers will be elected based on an application and interview with current officers. Current officers rerunning for the same or a different position may not be involved in their desired position's selection process.

ARTICLE VII. RISK MANAGEMENT

Club Golf at UC San Diego is a registered student organization at the University of California, San Diego, but not part of the University itself. Club Golf at UC San Diego understands that the University does not assume legal liability for the actions of the organization.
