ARTICLE I. NAME OF ORGANIZATION

The organization shall be called Alpha Omega Tampon at UC San Diego.

ARTICLE II. STATEMENT OF PURPOSE

Alpha Omega Tampon @UC San Diego serves as the UC San Diego chapter of the Alpha Omega Tampon satire sorority (established UCLA 2021). We aim to provide a supportive and fun community for the girls, gays, and theys of UC San Diego- as well as the chronically online.

ARTICLE III. NONPROFIT STATEMENT

Alpha Omega Tampon at UC San Diego is a non-profit student organization.

ARTICLE IV. REQUIREMENTS FOR MEMBERSHIP

Alpha Omega Tampon at UC San Diego does not require club dues. Club funds are based on event fees (only applicable at some events) and fundraisers.

All UC San Diego undergraduate students are eligible to apply for membership.

To become a member, interested students fill out a Google Form Application. They must then attend an Alpha Omega Tampon event, where they will sign in via QR code, before being offered General Membership status. Membership is yearly. Returning members fill out a separate application at the beginning of the year, sent to their email address.

### ARTICLE V. FREQUENCY OF ORGANIZATION MEETINGS

Our organization has bi-weekly (once every two weeks) General Member meetings (which non-members may attend). Board Meetings occur on an as-needed basis. Events are intermittent and based on Member Schedules and Board availability.

To maintain General Member status, one must attend at least 2 General Member meetings or events each school year. It is important to note that Membership status is not required for General Member meetings or most Alpha Omega Tampon at UC San Diego events.

The Secretary will record any voting and financial matters discussed and upload meeting slides to the Discord.

### ARTICLE VI. QUALIFICATIONS FOR HOLDING OFFICE AND METHODS OF SELECTING AND REPLACING OFFICERS

Only registered UC San Diego students may hold office in the organization. Only registered UC San Diego students may vote in elections for the selection of the organization's officers.

The amount of officers is flexible based on club size and membership. Officer positions will likely include President, Vice-President, Social Media/Marketing Manager, Events Committee Lead, Secretary, and Board Member at-large.

Officers form the Alpha Omega Tampon Board. All Board Members are required to also be General Members.

Officers are elected by current board members based on their application for the position.

Officers are elected on a yearly and as-needed basis by current Board Members.

All General Members are eligible for Officer status.

Officers assume their position after accepting their Board Member offer- sent via email.

Board Members are removed if

- a. They resign
- b. There is an issue with their ethics, behavior, or job performance. The process for such a removal is the same as the General Membership status removal process below.

In the event of a complaint, General Members are removed based on a two-part process. Firstly, Board Members will vote on the issue. With a majority removal vote, said Member may appeal to the General Members for a vote. If a quarter of the General Members vote said Member out, they are removed from membership status with Alpha Omega Tampon.

### ARTICLE VII. RISK MANAGEMENT

Alpha Omega Tampon at UC San Diego is a registered student organization at the University of California, San Diego, but not part of the University itself.

Alpha Omega Tampon at UC San Diego understands that the University does not assume legal liability for the actions of the organization.

### ARTICLE VIII. HAZING PREVENTION

Funds are stored in cash in the Club Safe. All transactions are recorded by the Secretary and/or Treasurer.
