### ■ ARTICLE I. NAME OF ORGANIZATION

The organization shall be called University Church Chinese Christian Fellowship (UCCCF) at UC San Diego.

#### ■ ARTICLE II. STATEMENT OF PURPOSE

- Through Christian faith fellowship and the teaching of biblical truth, we aim to cultivate character, value family values, and understand the eternal value and meaning of life.
- By connecting with local Chinese/Taiwanese people, students can obtain help in dorm and off-campus living while attending UCSD.
- Students will learn to overcome challenges from cultural and language differences, enabling them to focus on academic work without much hindrance from daily life.
- Through workshops and seminars, students will be equipped with the capabilities to analyze, conclude, present, and lead.
- Group activities will be organized primarily by the students to learn the skills for planning, execution, and leadership.

# ■ ARTICLE III. NONPROFIT STATEMENT

University Church Chinese Christian Fellowship (UCCCF) at UC San Diego is a non-profit student organization.

## ■ ARTICLE IV. REQUIREMENTS FOR MEMBERSHIP

Membership in University Church Chinese Christian Fellowship (UCCCF) at UC San Diego shall be open to any student, consistent with the Nondiscrimination Policy Statement for University of California Publications regarding Student-Related Matters. Membership is open to all students, and there are no dues required for membership.

# ■ ARTICLE V. FREQUENCY OF ORGANIZATION MEETINGS

The University Church Chinese Christian Fellowship (UCCCF) at UC San Diego will meet bi-weekly. Minutes will be taken during official meetings to disseminate information to members who are unable to attend and to record organization procedures and decision-making processes.

# ARTICLE VI. QUALIFICATIONS FOR HOLDING OFFICE AND METHODS OF SELECTING AND REPLACING OFFICERS

Only registered UC San Diego students may hold office in the organization. Only

registered UC San Diego students may vote in elections for the selection of the organization's officers.

#### Officer Positions and Duties:

<u>President:</u> Oversees all activities and represents the organization. <u>Vice President:</u> <u>Assists the President and coordinates events</u>. <u>Treasurer:</u> Manages finances and budget. Secretary: Records minutes and handles communications.

#### • Election Process:

Officers are elected annually in May for the following academic year. Elections are conducted by secret ballot during a regular meeting. Officers assume their positions on June 1st. In case of vacancy, a special election will be held.

#### Removal of Officers:

An officer may be removed for failure to perform duties or for conduct detrimental to the organization by a two-thirds vote of the members.

#### ■ ARTICLE VII. RISK MANAGEMENT

University Church Chinese Christian Fellowship (UCCCF) at UC San Diego is a registered student organization at the University of California, San Diego, but not part of the University itself. The organization understands that the University does not assume legal liability for the actions of the organization.

## Risk Management Strategies:

Regular safety training for members involved in events. Adherence to UC San Diego policies and procedures. Ensuring all activities are supervised and conducted in a safe environment.

# ■ ARTICLE VIII. HAZING PREVENTION

University Church Chinese Christian Fellowship (UCCCF) at UC San Diego strictly prohibits any form of hazing. Members will be educated on identifying and reporting hazing. Any incidents of hazing will be reported to the appropriate authorities and will result in disciplinary action.
