ARTICLE I. NAME OF ORGANIZATION

The organization shall be called "DND Club" at UC San Diego.

ARTICLE II. STATEMENT OF PURPOSE

DND Club at UC San Diego's purpose is to bring together students to partake in tabletop RPG activities including, but not limited to, Dungeons and Dragons. In this social club, students will be able to collaborate on a variety of campaigns and stories. The overarching purpose of the club is to unite students through our passion for the tabletop RPG genre, and foster a community of like-minded individuals.

ARTICLE III. NONPROFIT STATEMENT

DND Club at UC San Diego is a non-profit student organization.

ARTICLE IV. REQUIREMENTS FOR MEMBERSHIP

Any UC San Diego undergraduate student is able to join DND club at UC San Diego. There are no fees, however it is suggested that you bring supplies (including, but not limited to, dice, character sheets, and any resources you may require). As long as members are respectful to each other, there is no strict requirements for membership. Membership in DND Club at UC San Diego shall be open to any student, consistent with the Nondiscrimination Policy Statement for University of California Publications regarding Student-Related Matters.

ARTICLE V. FREQUENCY OF ORGANIZATION MEETINGS

Sessions will be held every two weeks (unless otherwise notified). This frequency can be changed depending on the schedules of those involved, but is mainly up to the discretion of the leading officials. General Body Meetings (GBMs) will be held twice a quarter (once within the first 5 weeks, and again in the second 5 weeks) each quarter to discuss plans for everyone's sessions, as well as keep track of progress.

ARTICLE VI. QUALIFICATIONS FOR HOLDING OFFICE AND METHODS OF SELECTING AND REPLACING

OFFICERS

Only registered UC San Diego students may hold office in the organization. Only registered UC San Diego students may vote in elections for the selection of the organization's officers.

There will be at least 3 officer positions including, but not limited to, President, Vice President, and Treasurer. These positions will be chosen on a volunteer-basis, but a club-wide election will be held for positions with multiple contenders.

President: Will manage the major proceedings of the club, including planning events, leading club meetings, and overseeing other officer positions if necessary.

Vice President: Will assist in managing major proceedings of the club, including event planning, leading meetings, and taking over in the event that the President is unable to perform their duties temporarily.

Treasurer: Will be in charge of tracking club resources including dice, character sheets, ongoing sessions, and funds.

Others: All other club officers will be delegated as general club managers and will oversee club sessions and meetings, assisting where necessary.

ARTICLE VII. RISK MANAGEMENT

DND Club at UC San Diego is a registered student organization at the University of California, San Diego, but not part of the University itself.

DND Club at UC San Diego understands that the University does not assume legal liability for the actions of the organization.

There are few major risks involved with DND Club at UC San Diego's activities, but it is required that a person feeling ill or a person who has had symptoms of illness within the past week refrains from attending sessions in-person, and opts for a remote, online alternative.

ARTICLE X. FINANCIAL MANAGEMENT

Financial management will be overseen by the treasurer, with assistance from the president. Due to the nature of the tabletop RPG genre, it is unlikely fundraising will be required, but in the case that it is, the planning of these events will be a joint effort of all club officers. As for club resources such as dice and other supplies, it is requested that club members opt for either their
