

THE CONSTITUTION

Article I. Name Of The Organization

1.1. The organization shall be called Glory Church Campus Fellowship at UC San Diego.

Article II. Mission And Purpose

2.1. The mission of this organization is to promote the Gospel of Jesus Christ, to promote faith in the Trinity God and His Bible, and to promote love and peace within communities with voluntary services. Provide students with a safe and fun space to explore and discover their faith in Jesus Christ.

2.2. This organization strives to build a fellowship within the walls of UC San Diego and to meet the spiritual needs of local Christians at UC San Diego.

2.3. All the actions of this organization will be bound by the Bible, the constitution and any organization regulation of UC San Diego.

2.4. Members of this organization will gain the opportunity to harness the following values and skills:

- 2.4.1. Friendship
- 2.4.2. Leadership
- 2.4.3. Spiritual understanding and growth
- 2.4.4. Emotional and spiritual support
- 2.4.5. Sense of belonging
- 2.4.6. Biblical knowledge

Article III. Nonprofit Statement

3.1. Glory Church Campus Fellowship at UC San Diego is a non-profit student organization.

Article IV. Requirements For Membership

4.1. All members of this organization must be students (including Undergraduate and Graduate) at UC San Diego.

4.2. We welcome all students who are willing to join our event without any monetary fees.

4.3. Students who have repeatedly shown up or shown an interest in our organization will be considered as active members.

Article V. Frequency Of Organization Meeting

5.1. This organization meets every Friday at 6:30 pm during each academic quarter.

5.2. This organization hosts an active members' meeting each week according to members' calendars and schedules.

5.3. The chairman of this organization will take minutes.

Article VI. Qualifications For Holding Office And Methods Of Selecting And Replacing Officers

6.1. Only registered UC San Diego students may hold office in the organization. Only registered UC San Diego students may vote in elections for the selection of the organization's officers.

6.2. The officers of this organization consist of a President, a Secretary, a Bible Study Officer, a Band Leader and three Advisors.

6.3. The officers of this organization will be selected based on personal preferences and popular vote.

6.4. Maximum length of service of a President should not exceed one year.

6.5. Length of service of other officers will be based on their own personal will and Section 6.6.

6.6. Eligibility of becoming an officer belongs to any member of the Glory Church Campus Fellowship (who should also by default a Christian)

6.7. An officer will be automatically removed from his/her service if one or more of following happens:

- 6.7.1. The officer graduated from UC San Diego
 - 6.7.2. The officer has renounced Christianity as his/her faith.
 - 6.7.3. The officer no longer fit for his/her service due to physical reasons
 - 6.7.4. The officer is no longer willing to continue his/her service to the fellowship.
- 6.8. Should one officer be removed, an emergency meeting will be held by at least 70% principle members to decided the replacement and all changes should be updated to all principle members,

Article VII. Frequency And Location Of Organization Meeting

- 7.1. This organization may periodically hold Principal Member meetings at one of the UC San Diego Price Center college rooms.
- 7.2. If not specited, Friday events of this organization will be held at 9888 Carroll Center Dr.
- 7.3. The location of events may change over time, and will be noted in the constitution\ under Article VII, Section 7.2.
- 7.4. Based on specific circumstances, the principal members and advisors have the right to determine or change location of events.

Article VIII. Risk Management

- 8.1. Glory Church Campus Fellowship at UC San Diego is a registered student organization at the University of California, San Diego, but not part of the University itself.
- 8.2. Glory Church Campus Fellowship at UC San Diego understands that the University does not assume legal liability for the actions of the organization.

Article IX. Community Advisor

- 9.1. The advisor of this organization will be selected by the Glory Christian Church of San Diego.
- 9.2. The length of the advisors' services will be determined by their own will and the will of Glory Church Campus Fellowship.
- 9.3. The advisors serve to support spiritual growth of this organization as well as to provide help for all events held by this organization.

Article X. Financial Management

- 10.1. Our activities do not involve costs of any sort. In very circumstances, our costs will be sponsored by GCCSD, which we are affiliated with.
- 10.2. Our operations do not involve costs in most circumstances.
- 10.3. Our organization does not have an off-campus bank account.
- 10.4. Our organization will not submit a budget of any form to A.S. or G.S.A. finance committee quarterly.

Article XI. Affiliation With Other Groups

- 11.1. Our organization is affiliated with Glory Christian Church of San Diego.
- 11.2. Our organization is a branch of fellowships associated with GCCSD, which means that our organization members are invited to join religious service at the GCCSD and participate in other GCCSD activities.
- 11.3. Members are expected to have good moral and behavioral standards.
