

## **SUNNY ANGELS AT UC SAN DIEGO CONSTITUTION - 2024-2025 ACADEMIC YEAR**

### **ARTICLE I. NAME OF ORGANIZATION**

The organization shall be called Sunny Angels at UC San Diego.

### **ARTICLE II. STATEMENT OF PURPOSE**

Sonny Angels are a world-wide phenomenon: cherub figurines that wear a variety of themed hats and accessories. The purpose of this student organization is to create and bring like-minded individuals together to celebrate and collect Sonny Angels.

### **ARTICLE III. NONPROFIT STATEMENT**

Sunny Angels at UC San Diego is a non-profit student organization.

### **ARTICLE IV. REQUIREMENTS FOR MEMBERSHIP**

There is no fee required to become a member of the organization. Members must be UC San Diego students. Membership includes filling out a google form. Perks of becoming a member include receiving a membership card with a discount at qualifying stores.

Membership in a Registered Student Organization shall be open to any student, consistent with the Nondiscrimination Policy Statement for University of California Publications regarding Student-Related Matters. (UCOP Policy on Registered Campus Organizations, Section 70.10).

### **ARTICLE V. FREQUENCY OF ORGANIZATION MEETINGS**

The organization will hold a GBM every month, with occasional social and workshop events throughout the month as well. There is no required number of meetings. Officers will meet bi-weekly to discuss the state of the club as well as current and future events. There will be meeting notes taken during these meetings.

### **ARTICLE VI. QUALIFICATIONS FOR HOLDING OFFICE AND METHODS OF SELECTING AND REPLACING OFFICERS**

Only registered UC San Diego students may hold office in the organization. Only registered UC San Diego students may vote in elections for the selection of the organization's officers.

There are 6 officer positions: President, Vice President, Secretary, Treasurer, Creative Director, and Event Coordinator. However, in the founding year, there were 2 presidents with no vice president. The officers will constitute an executive committee/board. Officers will go through an application process at the end of spring quarter where they will fill out an application and go through an interview. The board will then choose the best candidates for each position. There is no term limit. The officers will hold the position from summer of the academic year to the end of spring quarter, where they will help transition the new officers. Recruitment shall occur as needed throughout the academic school year to ensure the smooth operations of the organization. Any registered member is eligible for office. If an officer is not fulfilling their outlined duties, there will be a general body vote to terminate the officer. A new officer will then go through an expedited process of getting added onto the board. If a general member violates UC San Diego community guidelines, that member will be removed from the organization. They will not be allowed to attend any events hosted by the organization for the rest of the academic year. There will be an evaluation if that member wants to become a member again for the next academic year.

President: oversees the organization, runs officer meetings, obtains collaborations and sponsorships, manage website

Vice President: assisting the president in duties, cover any president duties if the president isn't available

Secretary: taking officer meeting notes, organizing and maintaining membership records

Treasurer: manage club funds, organize fundraisers, apply for AS funding

Creative Director: manage social media, manage publicity, create flyers and marketing materials

Events Coordinator: create and execute events
