#### TRITON FORTNITE CONSTITUTION

## Article I. Name of Student Organization

The organization shall be called Triton Fortnite at UCSD.

# Article II. Statement of Purpose

Triton Fortnite is a student organization whose goal is create a supportive and inviting environment to Fortnite players and enthusiasts. We will be hosting many online and in-person events (some collaborating with Triton Gaming) that promotes both competitive and casual play. Our goal is to have as much fun as we possibly can!

#### Article III. Nonprofit Statement

Triton Fortnite is a non-profit student organization.

# Article IV. Requirements for Membership

Club members may not be on academic or social probation. Members shall not be discriminated against based on the following:

- 1. Year of Graduation
- 2. Gaming Aptitude
- 3. Personal views on the current roster of officers
- 4. Gender or sexual orientation
- 5. Association with any other gaming or non-gaming organization

#### Article V. Frequency of Organization Meetings

- Section 1. There must be public notice of club meetings on the club board at least five (5) school days in advance.
- Section 2. There must be a meeting at least once a month held at University of California, San Diego.
- Section 3. There must be a quorum (a quorum is 50 percent plus 1 of the active or dues paying membership) present in order to take care of financial action.
- Section 4. Minutes must be kept of all financial action with the club secretary.

The treasurer will need to make a written and oral Section 5. report at least once a month at the meeting.

# Article VI. Qualifications for Holding Office & Methods of Selecting & Replacing Officers

Only registered UCSD students may hold office in the organization. Only registered UCSD students may vote in elections for the selection of the organization's officers.

Section 1. Club officers must be currently enrolled, have a minimum of a 2.0 cumulative Grade Point Average (GPA), must maintain at least 8 units per quarter, and must not be on academic or social probation.

Officers will be a President, Vice-President, Secretary, Event Manager, and General Officer.

Section 2. Club elections will be held no later than May 1st.

Section 3. The election will be done by secret ballot by club members who have attended at least two meetings and are current UCSD students.

#### Article VII. Risk Management

Triton Fortnite at UCSD is a registered student organization at the University of California, San Diego, but not part of the University itself.

Triton Fortnite at UCSD understands that the University does not assume legal liability for the actions of the organization.

Section 1. In Case of Interaction with Minors and/or the Elderly

Triton Fortnite at UCSD is aware that all registered student organizations that serve minors or the elderly have access to

training on child and elder abuse prevention for its members via the Center for Student Involvement, online or in person (in person by request only). Triton Fortnite will develop plan(s) for activities and events where members will be interacting with minors or the elderly such that members will receive education and/or training on Child Abuse Neglect Reporting Act (CANRA), common sense measures to both avoid child or elder abuse allegations (i.e. avoiding one-on-one situations; working with minors in plain view of others; limiting calls/texts/social media posts or other communications with minors), and how to properly report potential harm or neglect to minors or the elderly with whom they are working.

## Article X. Affiliation With Other Groups

- 1. Triton Fortnite is affiliated with Triton Gaming, a student organization at UCSD.
  - a. This affiliation does not impact the members of Triton Fortnite
  - b. This affiliation does not alter the requirements of Triton Fortnite or its members.
